Trainers and Committee Members by virtue of the unpaid Volunteer work they perform are deemed to be not in arrears of fees due to the club and are considered Financial Members. A volunteer performing duties approved by the Committee of the club is also deemed to be a financial member.

AMENDMENT TO THE RULES OF ASSOCIATION


Rule 38. Voting

- (1) On any question arising at any meeting of the Club, a member has one vote only.
- (2) All votes must be given personally. Vote by proxy is invalid.
- (3) In the case of an equality of votes on a question at a General Meeting, the chairperson of the meeting is entitled to exercise a second or casting vote.
- (4) A member is not entitled to vote at any meeting of the Club unless the member is a financial Club member at the time of the meeting, pursuant to Rule 4 Clause (16)

PROPOSED AMENDMENT

Rule 38. Voting

- (1) On any question arising at any meeting of the Club, a member has one vote only.
- (2) All votes must be given personally unless the Secretary of the Club receives a valid Proxy Form prior to the AGM or General Meeting. A Proxy must be a member of the Club.
- (3) In the case of an equality of votes on a question at a General Meeting, the chairperson of the meeting is entitled to exercise a second or casting vote.
- (4) A member is not entitled to vote at any meeting of the Club unless the member is a financial Club member at the time of the meeting, pursuant to Rule 4 Clause (16)
